- **Open board positions interest** Ballot goes out June 1st and closes June 10th. FSC has interest in all open positions including Lower Division rep, UIC, VP, Field Coordinator/Scheduler, Concessions, Fields & Equipment. With the shift in members, the current members agree a different location for board meetings might better fit our needs. Some options we will look into are the Sports Complex, the Folsom community center, or the community room in Bel-Air. The board would also like to provide food for both July and August board meetings with a budget of \$200.

- **NorCal/FAA** Registration opens 6/2 through 7/13 for Fall ball. The season begins 9/14 through the end of October. The city has about \$6000 for FSC to decide on where to spend the funds. The board agrees L3 could benefit from better shade options, the bullpens need pads and dirt at the Livermore fields. L1 and L3 need electrical work as well.
- **Summer Meeting Topics** Fine tuning FSC bylaws is a top priority this summer. Additional topics include the 1hr 20min game time for 12U age is insufficient. Playoff game coin-toss, 8U slap hitting, and having better representation for each age group at closing ceremonies will be discussed. USA softball is now saying Select will not be allowed to be played the same time as Rec which is a change from previous years. FSC wants to be able to provide practice shirts for teams in addition to jerseys. FSC hopes to pre-plan the season's fundraising opportunities and provide a flyer with uniforms so families can better plan to support fundraising opportunities. FSC would like to have a video or instruction sheet with pictures to help with field prep.
- **Fall Ball/ Volunteer Fees** All volunteer hours have been credited and all \$100 volunteer fees have been refunded. Total volunteer fees collected through spring registration was \$23,400. Total Volunteer fees refunded (hours satisfied) \$11,600. Total volunteer fees forfeited (at time of registration) \$4,500. Total volunteer fees forfeited (hours not fulfilled) \$7,300.
- **Fundraising** Shara will make sure an email will go out announcing firework stand sign ups as a volunteer opportunity. Sign up will be available through the website.
- **Retail/Venmo** we are still locked out of Venmo, it has been confirmed money is in the account but the amount is unknown. Alex was able to search for the last four digits of the verification

phone. Alex found who it likely belongs to and we will be in touch to try and get into the Venmo account. We will look into Google voice as a set phone number for FSC Venmo account as it is free for nonprofits.
